GARBAGE & RECYCLING

PICKUP FROM RESIDENCES AND BUSINESSES IS EVERY THURSDAY; PLEASE HAVE IT AT YOUR CURB BY 6:00 AM.

*For residences with seasonal pick-up, pick-up **begins** the 1st Thursday after May long weekend and **ends** the 1st Thursday after Thanksgiving.

GARBAGE: Current Bag Limit is 2 bags per residence and 8 bags per commercially assessed property. Each bag shall not exceed 40 lbs in weight.

RECYCLING: one week is the collection of fibers (paper & cardboard) and the next week is the collection of commingle (cans, plastic & glass).

Additional bag tags are available for \$2.00 each at the Township office and the Massey and Webbwood libraries.

The Council of the Township of Sables-Spanish Rivers has entered into an agreement with Wenrick Kennels Inc., for the provision of bylaw enforcement services. This includes but is not limited to:

Parking: This is a reminder that pursuant to Bylaw 2009-40 no persons shall park a vehicle on any municipal road allowance between the hours of 2a.m. and 8a.m., or during other periods of snowplowing operations, from November 1st to March 31st, except for emergency and health care vehicles. Any vehicles interfering with snowplowing operations can be ticketed or towed away at the owner's expense.

Property Standards: Upon receipt of a written, signed complaint the Bylaw Enforcement Officer shall commence an investigation of the infractions set out in the complaint and proceed as deemed required.

Zoning Bylaw: The Bylaw Enforcement Officer shall provide enforcement services where the use of land or any building, structure, or use thereof is a violation of the provisions of this bylaw.

BUILDING DEPARTMENT

The Building Inspector (Jeff Lapierre) is in the office on Mondays, Wednesdays and Thursdays (8am-4pm). If you require an inspection, please be sure to call at least 2 days in advance of when the inspection is required (The 2-day notice does not include the day that the inspection was requested).

REDUCED LOAD PERIOD ON MUNICIPAL ROADS SHALL START ON THE 1ST OF MARCH AND IS IN EFFECT WHILE THE APPROPRIATE SIGNAGE IS ERECTED. Please be reminded of this when planning your building projects.

STORAGE CONTAINERS, STORAGE TRAILERS AND SEA-CANS

Storage container means a pre-fabricated metal or steel accessory building used for the transport and/or storage of goods and materials.

Please take notice of the regulations respecting storage containers – Zoning Bylaw Section 4.32, 4.33 and Table 4.32. The following summarizes where storage containers are permitted:

Item	Residential Zones	Commercial Zones	Industrial & Rural Zones
Number of Storage Containers and Storage Trailers (Units) permitted per lot	-not permitted in R1, R2, and MHP -1 storage container per dwelling unit in Resource Recreation as an accessory use -Storage trailers are prohibited in any residential zone	-maximum of 3 units whether storage containers or storage trailers or a combination thereof in a C, CR and CL zone only - no limit where the C and CR permitted use is for the commercial display and sale of storage containers or where the permitted use is a commercial self-storage facility	- maximum of 3 units whether storage containers or storage trailers or a combination thereof in any Industrial Zone and in a Rural Zone for a non-residential use with a minimum 0.4 ha lot area -one (1) additional unit shall be permitted for each additional 4 ha of land area in a Rural Zone only, up to a maximum of 10 total -not permitted in any source protection, environmental and open space zones

The remainder of Table 4.32 sets out additional regulations and requirements. A complete copy of Table 4.32 in the Zoning Bylaw, is available on the Township website, or by calling the municipal office and requesting a copy.

If you are unsure if this is a permitted use on your property, please call the office. Also note that where permitted, a storage container requires a Building Permit prior to being placed on the property.

POST YOUR NUMBER

We can't help you if we can't find you. Make sure that your civic number is posted in front of your home or business, and that it is clearly visible from the road day or night. This will assist police, firefighters and paramedics in being able to locate you as quickly as possible if an emergency should occur. Getting resources where they are needed is vital, especially when dealing with 911 emergencies.

TAX BILLINGS - Payment of the 2021 Interim Property Tax Bill is due by February 28th, 2021. Late payment charges of 1.25% will be added to the balance still outstanding on March 1st, 2021.

WATER BILLINGS - The 1st quarter Water billing is due by March 31st, 2021.
