Interim Report Q-3 2022

Providing Animal and By-Law Enforcement Services continues to be challenging. The Pandemic, the Opiod crisis, Economic issues including the high price and scarcity in building materials and the scarcity of skilled workers, continue to be very real problems that many Sables Spanish residents face that have compounded many residents' ability to work to bring their properties up to standard.

We have had some success in moving number of cases forward. Initial inspections have been completed on all matters, with follow up inspections, notices, and orders issued in several matters. A summons to court was issued in one Property Standards case, however the Provincial Offence System is perhaps no longer the best way for dealing with By-Law contraventions. The problems with the Provincial Offence System have been greatly exacerbated by the Pandemic and are no longer offering us an effective means of providing enforcement.

We continue to work on bringing an Administrative Monetary Penalty System in our service areas. We have completed a draft AMPS bylaw and are in talks with the administration at the Town of Espanola on the logistics of establishing such a system across the LaCloche Foothill service area. More robust Property Standards, Animal Control and Winter Control By-Laws are also priorities that need to be addressed. The Enforcement process and by-laws need to be streamlined and improved to bring more immediate and consequential penalties into play for those who do not comply with by-laws in order to deliver the results that residents expect.

8.1 Grants and Funding: The annual application for the Public Library Operating Grant (PLOG) has been submitted.

The CEO submitted a proposal for a Trillium Capital Grant, as part of an application submitted by the Township. This grant would provide an outdoor book drop-off bin for the Webbwood Branch, replacement of flourescent lighting by LED fixtures at the Massey Branch, and new outdoor signage for the Massey Public Library. A decision regarding this grant application is expected in December or January.

Serena has also applied for funding from the Northern Ontario Heritage Fund for new signs, a heat pump (Massey) and a 3-D printer.

- 8.2 Quarterly Circulation & Attendance: This report was examined by the Board.
- 8.3 Programming & Events:

8.4 Technology:

a) Printer in Massey – is not working well and needs to be replaced. The Board discussed options, ie. refurbished or new. Funding for this purchase was considered and the Board recommended that Serena purchase a new machine, with a service agreement if possible.

b) Telescope Donation – Dave and Carolyn Dortwood (Webbwood) have donated a

telescope for loan to library patrons (Serena is drawing up a loan agreement and borrowing conditions). It was suggested that the CEO send a thank you to the Dortwoods expressing the appreciation of the Township Library Board for their generous donation and library participation.

8.5 Human Resources:

a) The position of library assistant (10-12 hours/week) was vacated in the summer.

The CEO discussed with the Board the possibility of increasing the hours for this position in order to attract and keep staff. It was agreed to include up to 20 hours per week for this position in the upcoming budget. Currently, a student in the Library & Information Technician program at Mohawk College (Thomasina Cuthbert) will be working at the Township libraries as a part of her course. She will work 10-12 hours per week (paid by the college). The Sables-Spanish Public Library was the only local placement option for Thomasina (she lives in Elliot Lake and the CEO of that library and the one in Spanish are not accredited – a requirement for this program).

b) Communication between staff and CEO – has been sporadic and inadequate of late (involving patron inquiries, etc). Serena has initiated a daily staff check-in which has led to some improvement in this essential area.

8.6 Friends of the Library:

Ursula Robinson addressed the recent initiative by the *Friends* group – *First Friday: The Art of...* The first session was attended by 10 people and was well-received. The October event will have three presenters, as will the event in November. It was decided that the December event, which will coincide with the **Christmas in Massey** evening, will feature only one presenter. However, on that night the Massey Branch will be open and will include the annual Silent Auction.

1. Arena Sound System

It was discussed that the issue with the sound during council meetings was not due to the arena's equipment. It is in fact the unidirectional microphone not being close enough to council members during the recording of the meetings at the arena that is the actual complaint. We recommend that a USB extender be purchased for the recording of the meetings when at the arena and that a second Unidirectional microphone be purchased to connect to the arena sound system so that attendees at the back can hear council members better as well. It was also discussed that Shawn did set up the microphone for the all candidate's night and that Moose FM decided not to use them and just said that we couldn't get them to work, which was not entirely the case. One of two microphones did not work and Shawn suggested we could have shared the microphone just requires a wire to be soldered then it should work. It was agreed that if the repair did not work we would just replace it.

2. Tree Update

Six Autumn blaze Maple trees were purchased to be placed around the playground to create shade during the summer months. On this day (October 19th, 2022) there had already been two planted at the Webbwood playground site and the other four were scheduled to be planted the following day of our meeting. October 20th, 2022 the additional 4 trees were planted, two in Massey at Massey Memorial Park and two in Walford adjacent to the playground at the park.

3. Mouth Park Bollard Update

Removable bollards were installed and completed. Padlocks were purchased and the bollards are locked.

4. Update Winter Programing Registrations/Sponsorships

Informed the committee that registrations are going well for most of the programming and that several people/business' have come forward to sponsor a child to play.

5. Public washrooms Heritage Park

We informed the committee of the issues and why we decided to close the washrooms early. Two of three toilets need to be replaced. We also recommended that a sharps container or a needle disposal can like in Webbwood be placed on site to the right of the women's washroom.

6. Arena Fence new option

A new option for the fence at the arena was brought to my attention by Shea Construction based out of Webbwood. It's a modular fence with metal I-beam posts. It accepts a wide range of panels including advertisement panels. The benefits of a modular fence are if someone were to back into it, only a small section would need to be replaced. It would also open up the sale of advertisements and allow the fence to pay for itself. You can also add benches to it off the back (facing the field for parents to watch soccer games sit and relax while the kids play. Shea Construction will be providing photos of one that he has completed in another community that also has the benches. The panels can be as simple as fence boards, coroplast panels, chain link panels and more.

7. Hiring staff

We discussed the possibility that two new staff were to be hired, One Operator and one Arena Staff. The Operator would be the usual \$18/hr and the Arena Staff could be \$16/hr or slightly more with 24-36 hours per week. We discussed an applicant that seemed like he would be a good fit to the team. We would like to consider him for the Arena Staff position and if it is determined that he is insurable on the Olympia and other Equipment we could then train him accordingly.

8. Sand at the playgrounds Update

Informed the committee that task was completed and a load of play sand was delivered and spread around at each of playgrounds around the township. We also let them know that this also resolved the issue with the slide in Webbwood being to high at the bottom.

ADDITIONS TO THE AGENDA:

9. Webbwood Rink

It was recommended that Shawn create a staff report saying what places he contacted with their response or lack of response. He is also to contact Centre Ice rinks and Shea Construction to see if they would do the board install and get quotes from them for that. As a plan B he is also to ask about paying for them, ordering them to be built now, and then storing them till they can be delivered in the spring.

10. Canteen

It was discussed that Shawn order pop, chips, chocolate bars, and candy through the bar fund to sell both at the bar and the canteen until new budgeted funds are available.

11. Office Electrical Panel

It was discussed that the panel in the office be replaced in the near future. Shawn is gather a budget quote and add it to his operating budget for 2023

12. Truck Bed/box

It was discussed that truck bed be coated with linex box coating, priced out at approximately \$650 *plus taxes and it be oil coated yearly to protect the investment.*
